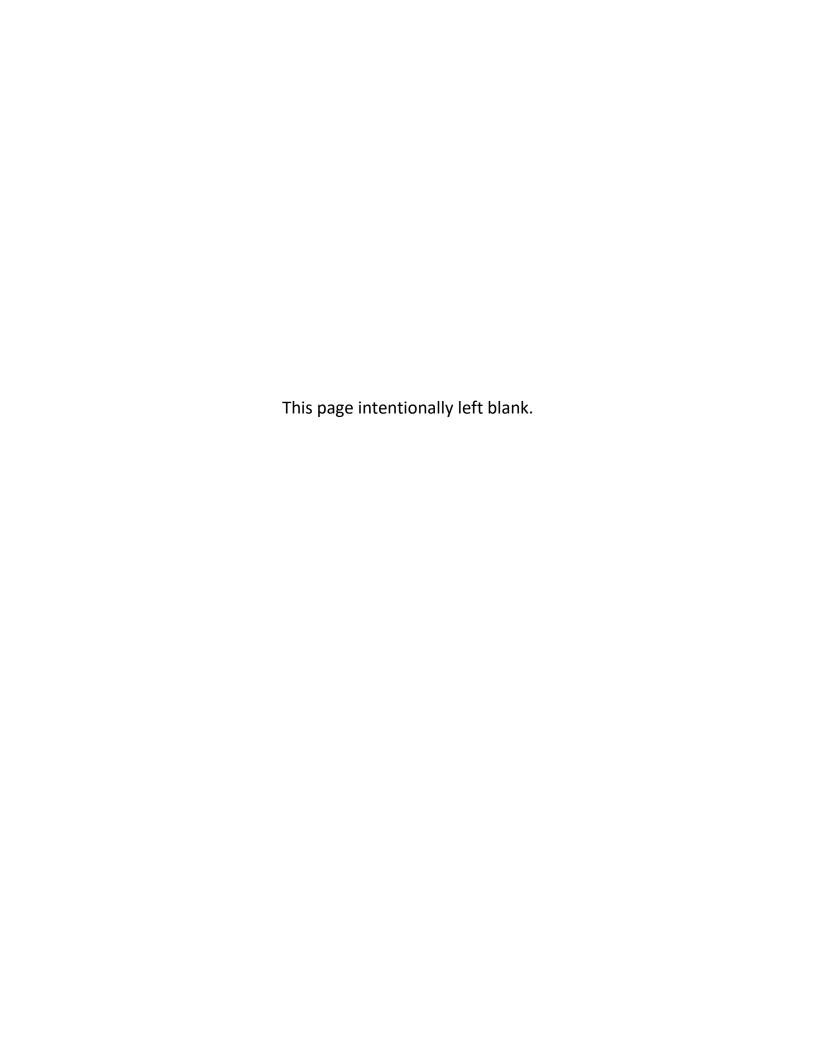

Administration Report

The elevator modernization was completed in mid-August and passed inspection. The base cost was \$164,468, with change orders, upgrades and infrastructure work bringing the project total to \$182,945.27. NEDSRA has paid for the project in full and has invoiced Addison for 50% of the expenses.

Director Barton and Manager Jimenez recently applied for a Bloomingdale Township Mental Health Board Grant and gave a presentation at the September 17 Township meeting. Recipients will be selected in October.

Manager Cline, Coordinator Fritsch, and Specialists Ross and Griffith served on the IPRA TR Summit Board of Regents this year. The Summit, held in September, was attended by nearly 90 professionals with engaging speakers covering a variety of topics.

Director Barton and Superintendent Goode hosted a NEDSRA table at the recent Disability Resource and Job Placement Expo hosted by Senator Lewis, Representative Grant and Representative Sanalitro. NEDSRA's own resource fair is November 8, and staff have asked legislators to include our information in their monthly emails to constituents.

Recreation

The beloved Fiesta de Verano returned on August 2, hosted at Addison Park District's Community Building with generous support from the Hispanic Parent Group. The event welcomed 167 attendees and featured dancers, food, music, and cultural activities — a true summer highlight.

On August 23, NEDSRA introduced "A Walk Through Nature" at the Itasca Park District's Springbrook Nature Center. Participants and family members explored the nature facility, engaged in hands-on activities, and enjoyed refreshments.

The weekend of September 6-7, five NEDSRA golfers earned medals at the State Golf Tournament and the Huskie Softball team earned silver. September 14, the volleyball team won third place at the Region C tournament and on September 21 the flag football team won gold in the qualifier, advancing to state later this fall.

The 2025–2026 EXCEL school programs launched in September, with sessions scheduled across special education classrooms in Member Partner districts and cooperatives. NEDSRA's recreation team is also delivering monthly adaptive art programming for selected classrooms serving multi-need populations.

The Jeena Greenwalt Scholarship will be awarded to two outstanding participants at the RISE celebration on November 14. Nominees are selected in-house based on financial need and demonstrated qualities of spirit, enthusiasm, happiness, and courage.

Marketing

The Golf Classic was a huge success with 148 registered golfers and 45 sponsorships, raising nearly \$50,000! Special thanks to the Glendale Lakes Golf Course for hosting the event and the entire Roesch Family for their continued partnership.

NEDSRA staff supported the Knights of Columbus Annual Tootsie Roll Drive September 12-13. Proceeds from this drive go to charities all around Illinois, including NEDSRA. Our team of staff were in Villa Park, Addison and Wood Dale, contributing over forty volunteer hours to a great cause.

Re: Health Insurance 2026

Annually the NEDSRA Trustees review and approve health insurance expenses in preparation for the open enrollment period.

NEDSRA maintains enrollment in the PDRMA Health program and is recommending that the agency continue to do so. In 2025/26 both PPO \$2,000 Deductible with \$1,500 HRA and HMO options were offered, along with dental with orthodontia, \$600 vision plan and gold vision plan.

13 employees participate in the health plan, with 1 opt-out. 13 employees are enrolled in dental, 5 employees in the Vision \$600 plan and 7 employees in the Vision Gold plan. NEDSRA anticipates similar demographics and enrollment in 2026.

PDRMA rates will increase 9.8% for PPO plans and 8.7% for HMO plans in 2026.

NEDSRA made several increases to employee percentages in 2025 and recommends additional changes for 2026. Those changes include the PPO and HMO Employee plans moving from 12% to 15% and the PPO and HMO Employee + Child plans moving from 15% to 18%. These changes are in line with Member Partner rates. The proposed rate changes will reduce agency costs approximately \$3,700. NEDSRA also recommends increasing the opt-out from \$2,750 to \$5,000.
